<p><b>At St. Hubert Catholic School we are committed to making our Catholic school a place where:</b></p> <ul style="list-style-type: none"> <li>• Students, parents, teachers and other school staff have the right to be safe, and to feel safe, welcomed and accepted;</li> <li>• Healthy and respectful relationships based on Christ's teachings are promoted among all members of the school community;</li> <li>• Students are encouraged to be leaders;</li> <li>• Students, staff, parents and community members are expected to be positive role models and actively engaged;</li> <li>• Positive behaviour is reinforced and celebrated;</li> <li>• The Catholic Graduate Expectations are emphasized and support the improvement of learning outcomes for all students;</li> <li>• Everyone is respected and valued.</li> </ul>
<p><b>Definition of Bullying (Bill 13)</b>  "bullying" means aggressive and typically repeated behavior by a pupil where,</p> <ol style="list-style-type: none"> <li>(a) the behavior is intended by the pupil to have the effect of, or the pupil ought to know that the behavior would be likely to have the effect of, <ol style="list-style-type: none"> <li>(i) causing harm, fear or distress to another individual, including physical, psychological, social or academic harm, harm to the individual's reputation or harm to the individual's property, or</li> <li>(ii) creating a negative environment at a school for another individual, and</li> </ol> </li> <li>(b) the behavior occurs in a context where there is a real or perceived power imbalance between the pupil and the individual based on factors such as size, strength, age, intelligence, peer group power, economic status, social status,</li> </ol>

religion, ethnic origin, sexual orientation, family circumstances, gender, gender identity, gender expression, race, disability or the receipt of special education; (“intimidation”)

For the purposes of the definition of “bullying” behavior includes the use of any physical, verbal, electronic, written or other means. Bullying includes bullying by electronic means (commonly known as cyber-bullying), including,

- (a) creating a web page or a blog in which the creator assumes the identity of another person;
- (b) impersonating another person as the author of content or messages posted on the internet; and
- (c) communicating material electronically to more than one individual or posting material on a website that may be accessed by one or more individuals.

### **Awareness Strategies**

- Complete climate survey a minimum of every two years;
- Celebrate Bullying Prevention week beginning the third Sunday in November;
- Peer mentoring (classes paired up) to support awareness and strategies related to bullying
- Quarterly review of the code of conduct, expected behaviors and definition of bullying with students and stakeholders through classroom visits, assemblies, newsletters, announcements, school council meetings, websites etc.
- School wide and class presentations from community agencies (North Bay Police etc.)
- School and classroom programs (Second Step, Rainbows, Drug Abuse Resistance Education - D.A.R.E., Religion & Family Life program, posters visible in halls)

### **Programs and Prevention**

#### **Individual Level:**

- Foster respectful relationships and understanding with those around you.
- Hold meetings with students and their parents when inappropriate behavior occurs.
- Support positive change and positive behavior.
- Develop individual intervention plans for students involved in serious incidents.

#### **Classroom Level:**

- Communicate positive behavioral expectations and consistently enforce school-wide rules on behavior.
- Hold regular class meetings/discussions and communicate regularly with parents.
- Give opportunities for social emotional learning to build and practice healthy relationships skills through classroom activities and programs.
- Embed the principles of respect, equity and inclusive education through curriculum resources and classroom practices.

#### **School Level:**

- Establish a Safe and Accepting School Committee.
- Provide training for staff.
- Conduct pre- and post-school climate survey results to inform practices.
- Establish and communicate school rules regarding behavior.

- Develop bullying prevention and intervention plans.
- Review and refine the school's supervision plan, which should identify areas presenting with challenges when it comes to supervision.

#### **Community Level:**

- Foster school-community partnerships to support the school's programs.
- Communicate the schools' Code of Conduct and expectations on appropriate behavior to the school community.

#### **Intervention and Supports**

Reporting incidents of bullying is the responsibility of all staff.

Reported incidents of bullying will be investigated and addressed through the teacher and/or principal/vice-principal. In addressing incidents of bullying keeping in mind mitigating factors such as age, circumstances, history, IEP, a progressive discipline approach which could include the following:

- contact with the pupil's parent(s)/guardian(s);
- verbal reminders;
- review of expectations;
- written work assignment with a learning component relevant to the behaviour;
- peer mentoring;
- detention;
- peer mediation;
- restorative justice;
- referrals for consultation; and
- transfer.

In some circumstances suspensions and expulsions may result.

#### **Supports and Follow-up**

- a) Incidents of bullying will be followed up with the students involved, the parents, the teachers and other school staff and community partners where appropriate.
- b) Students who engage in bullying, who have been bullied or may have witnessed or been affected by bullying will receive support which may include but is not limited to the following:
  - One on one and/or group meetings;
  - Learning opportunities;
  - Restorative justice;
  - Contracts or behavior safety plans;
  - Referrals to board-based supports and services;
  - Referrals to community partners.
